# **Case Management**

Many things can impact fostering a healthy family. A lack of a well-paying job, resources to provide health care, childcare needs, mental health, and substance abuse problems, a history of trauma, and many more challenges can create stress in a family and result in unnecessary conflict and, in some cases contribute to abusive behavior.

Case Management Services offers support and assistance to individuals and families experiencing some form of conflict and distress. Please call our office if you feel you could benefit from any of our services.

#### **Child Visitation Support**:

If you are currently separated from or otherwise having difficulties in having regularly scheduled visits with your child/Children, case management services can assist you in resolving issues in visitation with your child.

#### Social Determinants of Health (SDH)

**Survey:** We can help with a comprehensive review of your needs in the areas of health, transportation, utilities, and personal safety. This survey will assist in identifying needs that, if addressed, will reduce the potential for family conflicts and other stressors.

**Stress Management Group (SMG)**: The Stress Management Assessment can provide you with skills that can improve their ability to:

- · Improve communication Skills
- Problem-Solve
- Address conflicts in non-aggressive and health ways
- More effectively address child behavioral problems
- Reduce stress levels
- Equitable decision-making in relationships

#### Mental Health & Substance Abuse

**Screening:** Completion of a series of surveys will assist the participant in better determining if participation in a substance abuse or mental health program can contribute to reducing family conflicts.
